1. Any Student can register complaint/grievance either on the grievance link on website or dropping written complaint in the box provided on the wall near entrance .

3. SGRC Committee will investigate the complaint by inviting the grieving students' to listen their grievances.
4. All the Proceeding of the meeting shall be duly recorded in the register.
5. After listening the complaint of the students, the SGRC Committee will recommend appropriate remedial action to the satisfaction of the grievance in student.
6. The Action taken on the Grievance redressal shall be noted in Grievance register and signed by the SGRC members and Grieving Students for their satisfactory resolution of the complaint/grievance
7. A copy of the action taken report by SGRC on resolution of the complaint grievance /complaint duly signed by the SGRC Committee and Grievances student will be sent to university every month.
